Reports

Trenta called for reports.

Trenta announced that the Al-Anon Birthday Celebration starts at 1 PM today.

Verbatim from the report that Trenta sent to me:

- Attended the Board meeting on April 15th.
- Coordinated tasks for Birthday Fundraiser with Office Manager and Office-Chair: Signage posted on Gazebo, extra chairs for meeting, literature promo and acquiring volunteers for literature sales, printing flyers for distribution at AFG Speaker meeting.
- Announced the Birthday fundraiser and presented additional flyers for other members to share the announcement with their other meetings attended.
- Reached out to districts to assist in reminding the meetings about the birthday event.
- Coordinated cake donation, design and delivery with Bec, an Al-Anon member.
- Purchased Water bottles and candles for the event.

Comment: Elo volunteered to help with Spanish translation at the birthday celebration.

Treasurer: Cindi (absent)

Report from summary sent by Cindi. Report was presented by Vice Chair Trenta in Cindi's absence. Ex-Officio Kelly presented information about the Prudent Reserve Thought Force.

- I. <u>Balance Sheet</u> As of April 30, 2023, San Diego County Al-Anon Information Services Office held assets totaling \$159,068. This includes \$21,593 in literature inventory and \$865.58 in undeposited funds. The AIS Office continues to maintain cash reserves of approximately 18 months of expenses.
- II. <u>Statement of Income & Expense Documents</u> The Statement of Income & Expense with Current vs Previous Year comparisons as of April 30, 2023 are accessible along with all April 2023 financial documents located in the Governance folder.
- III. <u>FY23 Budget (Adj. 2/1/2023) Performance</u> Income for the month of April 2023 from Contributions was \$ 4,793.00, slightly under budget by \$440.00. Income from Literature sales was \$ 5,823, well over budget by \$2,340.00. Total income for the month of April was \$10,617.00.

Expenses for the month of April 2023 included the cost for literature purchases of \$ 3,964.00, which was over budget by \$1,214.00. Total expenses in April were \$ 7,469.00 which was over budget by \$1,199.00.

Net Income for the month of April 2023 was negative (\$ 815) - under budget by (\$ 972).

<u>Prudent Reserve Thought Force</u> - In March the Board voted to create a Thought Force with the following purpose: To brainstorm ideas, develop strategies and present a summary of options for consideration and approval of the board for use(s) of approximately \$17,500.00. The Board agreed to spend down this amount to bring the Prudent Reserve into alignment with recommended reserve amounts of one year of expenses.

Cindi, Anita, Dan, and Kelly met several times in April to launch the Prudent Reserve Thought Force and discuss ideas gathered from their Board colleagues for initial spending. At the April Board meeting the Thought Force presented and the Board approved initial spending on the following projects:

Werner showed the results of the ISR Survey:

- 50% of respondents prefer status quo, i.e., to continue to receive agenda and minutes from our Ex-Officio by email
- Only 23% would prefer documents on our website
- Decision: continue with Ex-Officio sending out an email for time being, possibly with a website page in parallel (to be decided)
- The survey also showed that the majority does not think that a password protected access to minutes or agendas on the website would be necessary
- Finally, over 92% of the responders are satisfied or extremely satisfied with the documents/information we send to the ISRs

Werner showed the Online Book Extension data. He analyzed 2022 sales. Nineteen items did not sell in 2022. Currently we cannot split sales from online, mail and walk-in orders. Werner also reported that:

- Website visits remain fairly stable
- People from 1587 cities in 69 countries have visited our website since Jan 1, 2023
- Main work since April 2023 Board meeting was focusing on the Online Bookstore structure and the selection of additional literature as part of the extension from 46 to 69 items

Werner reported on the ISR Survey:

- Werner thanked ISRs who participated in our survey
- 50% of respondents prefer status quo, i.e., to continue to receive agenda and minutes from our Ex-Officio by email
- Only 23% would prefer documents on our website

Verbatim from the report that Ron P sent to me:

2023 is the year to: "Find Your Place in Alateen"

Please join in sharing the latest Alateen outreach messaging containing: "Find Your Place in Alateen!". This messaging relates to everyone in or out of the program including Al-Anon and Alateen members, family, friends, and relatives, all who have considered and supported the Alateen program. Al-Anon is Alateen. We all can find a place in our hearts for Alateen because we all are affected!

San Diego seems to have a renewed interest in Alateen sponsorship and outreach overall. This is very encouraging and exciting and will hopefully continue and grow exponentially. Alateen member participation in San Diego County, however, continues to need support. Although there have been several new Alateen groups that have been established in recent months, the current active member status remains challenging.

This has occurred for many reasons including the pandemic, continued competition with "smart devices", and the need for educational and informational opportunities to be circulated. Among these are the public, professionals, schools and institutions, and the AA and Al-Anon memberships. One could be surprised at the number of folks out there that don't know what Alateen all is about!

The schools certainly have been one bright spot in that several of these new Alateen meetings have opened at middle and high school levels with members attending and hitting the ground running!

According to recent statistics, there is a large population of Alateen members among us. The following steps are some of the ways we hope to develop a long term and sustainable Alateen outreach program:

• School, Mental Health and Psychiatric Direct Mail Outreach - Repeated messaged mailings and or emails delivered several times annually to school administrators, counseling personnel and mental health professionals.

Many of these lists are available free of charge to the public. This would continue from year to year.

- Health and Wellness Exhibitions, Fairs, and Outreach Events Attend community markets, health and wellness fairs, and other outreach events with literature and outreach tables.
- General Membership Outreach Provide direct messaging, publications, hand-outs and education to the Al-Anon membership and public regarding Alateen benefits. Alcoholism is a family disease! 1 in 4 children are affected by someone's drinking. If not treated, these children have a 400% increase in the chances of incurring substance use disorders themselves.
- Sponsor and Meeting Outreach Alateen needs support in the form of Alateen sponsors and new meetings. Include outreach and messaging in your weekly meeting readings and openings. Discuss Alateen in your groups. Talk with your own children, and friends with children who may be suffering. Parents can be one of the greatest obstacles and enablers in not allowing a child to receive help!
- IT and Website Outreach Develop an enhanced presence for Alateen on the San Diego Al-Anon website. Currently there are only a few pages on the entire website devoted to Alateen. Create a workable hub that Alateens and Sponsors can easily access to communicate and post to regarding events, meeting support, sponsor need & substitutions, and outreach opportunities in general.
- Smart Device Apps Research and investigate smart device application access to teens. This could potentially be an extension or add-on of the current "Al-Anon" app.
